Annual Turnover is a measure of the trading activity in an investment portfolio — how often securities are bought and sold by a portfolio. Net Debt/Capital reflects a company's financial leverage as measured by its net debt (total debt minus cash & cash equivalents) divided by total capital. The aggregate calculation excludes companies classified by GICS as banks, consumer finance and capital markets to focus on nonfinancial liabilities.
