However, our investment thesis is driven by market share gains enabled by the company's reinvigorated product line. Despite the cyclical market correction underway, there remains solid evidence that Lattice continues to gain market share, and importantly, the company is just now launching a new medium-power Avant line of chips, which should be another catalyst going forward. Given our view that semiconductor downcycles tend to be short-lived, we are comfortable being patient for a reaccelerating profit cycle later in 2024.

Lattice Semiconductor is a fabless vendor of field programmable gate array chips that customers can program and configure to their specifications. Lattice shares have been under pressure for a

Our capital allocation process is designed to build position size according to our conviction. Portfolio holdings develop through three stages: GardenSM, CropSM and HarvestSM. GardenSM investments are situations where we believe we are right, but there is not clear evidence that the profit cycle has taken hold, so positions are small. CropSM investments are holdings where we have gained conviction in the company's profit cycle, so positions are larger. HarvestSM investments are holdings that have exceeded our estimate of intrinsic value or holdings where there is a deceleration in the company's profit cycle. HarvestSM investments are generally being reduced or sold from the portfolios.
